The application eligibility is based on the MOE's (Ministry of Education) "Regulations Regarding International Students Undertaking Studies in Taiwan." If the MOE regulations are revised, the latest MOE regulations shall prevail. For the latest MOE regulations, please refer to: <https://law.moj.gov.tw/ENG/LawClass/LawAll.aspx?pcode=H0110001>

一、國籍 Nationality：

(一)具外國國籍且未曾具有中華民國國籍^{註1}，於申請時並不具僑生資格^{註2}者。

An individual of foreign nationality, who has never held nationality status from the Republic of China (R.O.C.)¹ and who does not possess an overseas Chinese student status² at the time of their application.

(二)具外國國籍且符合下列規定，於申請時並已連續居留海外(不含香港、澳門及大陸地區)六年以上者(計算至 2026 年 8 月 1 日且每曆年在台灣停留時間不超過 120 日)。

An individual of foreign nationality, pursuant to the following requirements and who has resided overseas (excluding Hong Kong, Macau and Mainland China) continuously for no less than 6 years prior to August 1, 2026 and whose stays in Taiwan per calendar year do not exceed a total of 120 days.

1.申請時兼具中華民國國籍者，應自始未曾在臺設有戶籍。

An individual who also is a national of the R.O.C. but does not hold nor has had a household registration in Taiwan.

2.申請前曾兼具中華民國國籍，於申請時已不具中華民國國籍者，應自內政部許可喪失中華民國國籍之日起至申請時已滿八年。

An individual who also was previously a national of the R.O.C. but has no R.O.C. nationality at the time of their application shall have an annulled status regarding their R.O.C. nationality for no less than 8 years after an annulment of R.O.C. nationality by the Ministry of the Interior.

3. 前二款均未曾以僑生身分在臺就學，且未於當學年度接受海外聯合招生委員會分發。

Regarding individuals mentioned in the preceding 2 subparagraphs, they must not have studied in Taiwan as an overseas Chinese student nor received placement permission during the same year of the application by the University Entrance Committee for Overseas Chinese Students.

(三) 依教育合作協議，由外國政府、機構或學校遴薦來臺就學之外國國民，其自始未曾在臺設有戶籍者，經教育部核准，得不受前二項規定之限制。

According to the Education Cooperation Framework Agreement, a foreign national who was selected by a foreign government, organization, or school, and who has never held household registration in the R.O.C. is not subject to the limitations as prescribed in the preceding 2 paragraphs after receiving the approval from MOE.

(四) 符合下列情形之一且具相關證明者，不在此限；其在國內停留期間，不併入海外居留期間計算：

1. 就讀僑務主管機關舉辦之海外青年技術訓練班或本部認定之技術訓練專班。
2. 就讀教育部（以下簡稱本部）核准得招收外國學生之各大專校院華語文中心，合計未滿二年。
3. 交換學生，其交換期間合計未滿二年。
4. 經中央目的事業主管機關許可來臺實習，實習期間合計未滿二年。

The only exceptions to this method of calculation are for those who fulfill one of the following requirements with written supportive proof:

1. Attended overseas youth training courses organized by the Overseas Compatriot Affairs Council or technique training classes accredited by the Ministry of Education (the “Ministry”);
2. Attended a Mandarin language center at a university/college of which their foreign student recruitment is approved by the Ministry, and to which the total length of stay is less than 2 years;
3. Exchange students, whose length of total exchange is less than 2 years; or
4. An Internship in Taiwan which has been approved by an authorized central government agency, to which the total length of stay is less than 2 years.

(五) 具外國國籍，兼具香港或澳門永久居留資格，且未曾在臺設有戶籍，申請時於香港、澳門或海外(不含大陸地區)連續居留滿六年以上者(計算至 2026 年 8 月 1 日且每曆年在臺灣停留時間不超過 120 日)。

An applicant of foreign nationality, concurrently holding a permanent residence status in Hong Kong or Macao, having no history of a household registration record in Taiwan and, at the time of application, has resided in Hong Kong, Macao, or another foreign country (excluding Mainland China) for no less than 6 years prior to August 1, 2026 and whose stays in Taiwan per calendar year do not exceed a total of 120 days.

(六) 曾為大陸地區人民具外國國籍且未曾在臺設有戶籍，申請時已連續居留海外(不含香港、澳門及大陸地區)六年以上者(計算至 2026 年 8 月 1 日且每曆年在臺灣

停留時間不超過 120 日)。

An applicant being a former citizen of Mainland China and who holds foreign nationality, having no history of household registration records in Taiwan, and at the time of application, has resided overseas (excluding Hong Kong, Macau and Mainland China) continuously for no less than 6 years prior to August 1, 2026, and whose stays in Taiwan per calendar year do not exceed a total of 120 days.

二、學歷 Academic Background：

(一)符合教育部採認之高中、大學或獨立學院畢業者(請參考教育部國際及兩岸教育司網站)。申請學士班者須具國外高中畢業學歷、申請碩士班者須具大學畢業學歷、申請博士班者須具碩士畢業學歷。

Applicants who have graduated from a high school, college or university recognized by the Ministry of Education, R.O.C. can apply for admission (please refer to the website of the Department of International and Cross-Strait Education, Ministry of Education). International students with a high school diploma are eligible to apply for undergraduate programs; undergraduate degree holders may apply for a master's program; master's degree holders may apply for doctoral programs.

(二)具有與我國學制相當之同等學力資格者。

Applicants with equivalent qualifications to the academic degree system of Taiwan can apply for admissions.

【註 1】NOTE 1

根據「中華民國國籍法」第 2 條規定：有下列各款情形之一者，屬中華民國國籍：

According to Article 2 of the Nationality Law, a person who meets one of the following requirements acquires the nationality of the Republic of China:

一、出生時父或母為中華民國國民。

A person whose father or mother was, at the time of his/her birth, a citizen of the Republic of China.

二、出生於父或母死亡後，其父或母死亡時為中華民國國民。

A person born after the death of his/her father or mother, and whose parent was, at the time of death, a citizen of the Republic of China. *

三、出生於中華民國領域內，父母均無可考，或均無國籍者。

A person born in the territory of the Republic of China and whose parents are both unknown or are stateless.

四、歸化者。

A naturalized citizen.

* 前項第一款及第二款之規定，於本法修正公布時之未成年人，亦適用之。

Preceding Subparagraph 1 and Subparagraph 2 shall also apply to the persons who were minors at the time of the amendment and promulgation of this Act.

【註 2】NOTE 2

根據「僑生回國就學及輔導辦法」規定：「僑生畢業、退學或休學期滿，且未繼續就學者，中止僑生身分。僑生身分經中止者，於繼續升學、轉學或復學後，恢復僑生身分。」有下列各款情形之一者，為具僑生身分，不符合本項招生申請資格：

As stated in the Regulations Regarding Study and Counseling Assistance for Overseas Chinese Students in Taiwan, “Overseas Chinese Students that have graduated, been expelled, or suspended from their studies for longer than the maximum allowable duration will lose their status as an

Overseas Chinese Student. Students whose status has been temporarily suspended will resume their status upon returning to school.” Anyone meeting one of the following requirements is considered Overseas Chinese, and therefore is disqualified for applying as an International Student:

一、曾於臺灣以僑生身分申請或就讀。

Anyone having applied for studies or previously studied in any school in Taiwan as an Overseas Chinese.

二、報名「海外聯合招生委員會招會」所舉辦之僑生考試，且已登記志願獲分發。

Anyone having taken the university entrance exam for Overseas Chinese students held by the 'University Entrance Committee For Overseas Chinese Student', has filled out the choices of university/college and has been admitted to one of the universities/colleges.

One copy of the diploma of the highest academic degree. An original translation in English or Chinese of the diploma is necessary if the original is not in English or in Chinese, and it should be verified by the ROC representative office of the country where the document was issued.

Graduating students that have not yet received their diploma must submit an original copy of a Certificate of Expected Graduation issued by the school.

Academic credentials earned at overseas Taiwanese schools or Taiwanese schools in Mainland China shall be regarded as the same as those at domestic schools with equivalent levels.

Academic credentials referred to in the preceding two items shall be subject to the Regulations Regarding the Assessment and Recognition of Foreign Academic Credentials for Institutions of Higher Education. However, academic credentials earned from schools or branches established in Mainland China by foreign institutions shall require public notarization in Mainland China and be verified by an institute established or appointed by, or through a private agency commissioned by the Executive Yuan.

A financial guarantee statement indicating that the applicant has adequate financial support for the duration of his/her stay in Taiwan (at least USD 4,000 or NTD 120,000 for lay students, or at least USD 1,000 or NTD 30,000 for monastic students) or proof of full scholarship provided by a government agency, university, college, or private organization.

一、本規定依據教育部「外國學生來臺就學辦法」第六條規定訂定之。

二、外國學生申請入本校修讀學位或申請選讀本校課程者，依本規定辦理之。

本校招收外國學生應訂定外國學生招生簡章，其內容應包括招生方式、入學資格審查程序、學系(程)授課語言、學生應具備之語文能力基準、財力證明基準及其他相關事項。
每年依招生時程，公告於本校招生入學網頁、官方社群媒體，並透過法鼓山體系之網頁進海外宣傳。

本校辦理外國學生招生事務，除宣傳推廣及協助學生辦理來臺相關必要程序外，未委由校機構、法人、團體或個人辦理，且無向外國學生收取招生相關費用之情事。一切入學申請程序及規定，均依照本規定及當年度所訂之招生簡章為準。

三、符合下列身份資格之一者得依本規定申請入學：

(一)具外國國籍且未曾具有中華民國國籍，符合下列規定者，得依本規定申請入學：

1. 未曾以僑生身分在臺就學。

2. 未於申請入學當學年度依僑生回國就學及輔導辦法經海外聯合招生委員會分發。

(二)具外國國籍並符合下列規定，且最近連續居留海外六年以上者，亦得依本規定申請入學：

1. 申請時兼具中華民國國籍者，應自始未曾在臺設有戶籍。

2. 申請前曾兼具中華民國國籍，於申請時已不具中華民國國籍者，應自內政部許可喪失中華民國國籍之日起至申請時已滿八年。

3. 前二目均未曾以僑生身分在臺就學，且未於當學年度經海外聯合招生委員會分發。依教育合作協議，由外國政府、機構或學校遴薦來臺就學之外國國民，其自始未曾在臺設有戶籍者，經教育部核准，得不受前項規定之限制。

第一項第二款所定六年、八年，以擬入學當學期起始日期（二月一日或八月一日）為終日計算之。

第一項第二款所稱海外，指大陸地區、香港及澳門以外之國家或地區；所稱連續居留，指外國學生每曆年在國內停留期間不得逾一百二十日。連續居留海外採計期間之起迄年度非屬完整曆年者，以各該年度之採計期間內在國內停留期間未逾一百二十日予以認定。

但符合下列情形之一且具相關證明文件者，不在此限；其在國內停留期間，不併入海外居留期間計算：

(一)就讀僑務主管機關舉辦之海外青年技術訓練班或教育部認定之技術訓練專班。

(二)就讀教育部核准得招收外國學生之各大專校院華語文中心，合計未滿二年。

(三)交換學生，其交換期間合計未滿二年。

(四)經中央目的事業主管機關許可來臺實習，實習期間合計未滿二年。

具外國國籍並兼具中華民國國籍，且於「教育部外國學生來臺就學辦法」中華民國一百年二月一日修正施行前已提出申請喪失中華民國國籍者，得依原規定申請入學，不受第一項規定之限制。

四、具外國國籍，兼具香港或澳門永久居留資格，且未曾在臺設有戶籍，申請時於香港、澳門或海外連續居留滿六年以上者，得依本規定申請入學。

前項所稱連續居留，指每曆年在國內停留期間，合計未逾一百二十日。但符合第三點第五項第一款至第四款所列情形之一且具相關證明文件者，不在此限；其在國內停留期間，不併入前項連續居留期間計算。

曾為大陸地區人民具外國國籍且未曾在臺設有戶籍，申請時已連續居留海外六年以上者，得依本規定申請入學。

第一項及第三項所定六年，以擬入學當學期起始日期（二月一日或八月一日）為終日計算之。

第一項至第四項所定海外，準用第三點第四項規定。

五、本校實際招收入學之外國學生，其名額以教育部核定本校當學年度招生名額外加百分之十為原則，並應併入前一學年度招生總名額報教育部核定；申請招收外國學生名額超過前一學年度核定招生名額外加百分之十者，應併同提出增量計畫（包括品質控管策略及配套措施）報教育部核定。但本校與外國大學合作並經教育部專案核定之學位專班，不在此限。本校前一學年度核定招生總名額內，若有本國學生未招足之情形，得以外國學生名額補足，並須報教育部核定。第一項招生名額，不含未具正式學籍之外國學生。

六、申請入本校修讀學位之外國學生，應具備下列資格：

(一)符合修讀各級學位之入學資格或具有與我國學制相當之同等學力資格。

(二)未曾遭國內學校以操行、學業成績不及格或因犯刑事案件經判刑確定致遭退學之情形。

(三)學力資格：

在原畢業學校畢業平均成績及格或通過該國學制規定之畢業考試。

(四)華語文能力：本校各學系、學程為中文授課。申請人應具備華語文聽、說、讀、寫能力

1. 申請就讀學士班者，華語文能力相當於華語文能力測驗(TOCFL)A2 基礎級。

2. 申請就讀碩、博士班者，華語文能力相當於華語文能力測驗(TOCFL)B1 進階級。

3. 以下情形得免附華語文能力測驗證明：

(1) 申請就讀碩士班以上之學制，前一學制於我國就讀者。

(2) 出生地在中國大陸，以華語為母語者。

(3) 申請人為馬來西亞籍，且曾就讀於該國以華語教學之國民型中學或華文獨中者得免附上述華語文能力證明。

(五)初審合格者，本校得視需要，舉辦口試作業。

七、符合申請資格者，應依該學年度簡章規定期限檢具下列表件向本校國際事務組提出申請：

(一)入學申請表一式二份（各貼二吋脫帽半身照片一張）

(二)護照影本一份。

(三)學歷證明文件：

1. 大陸地區學歷：應依大陸地區學歷採認辦法規定辦理。

2. 香港或澳門學歷：應依香港澳門學歷檢覈及採認辦法規定辦理。

3. 其他地區學歷：

(1) 海外臺灣學校及大陸地區臺商學校之學歷同我國同級學校學歷。

(2) 前二目以外之國外地區學歷，應依大學辦理國外學歷採認辦法規定辦理。但設校或分校於大陸地區之外國學校學歷，應經大陸地區公證處公證，並經行政院設立或指定之機構或委託之民間團體驗證。

(四) 足夠在臺就學之財力證明(在家眾至少 NTD 120,000 或 USD 4,000，出家眾至少 NTD30,000 或 USD 1,000)，或政府、本校或民間機構提供全額獎助學金之證明。

外國學生在我國就讀外國僑民學校或我國高級中等學校附設之雙語部(班)或私立高級中學校外國課程部班畢業者，得持該等學校畢業證書及歷年成績證明文件，依第七點規定申請入學，不受第八點及第七點第一項第三款規定之限制。

八、外國學生依第三點及第四點規定申請來臺就學，以一次為限；其繼續在臺就學者，入學方應與我國內一般學生相同。但下列情形，不在此限：

(一) 於完成申請就學學校學程後，申請碩士班以上學程，得循與我國內一般學生相同方或以外國學生身份之二擇一方式，申請入學。

(二) 外國學生申請來臺就讀學士班以下學程，在國內停留未滿一年，因故退學或喪失學籍得重新申請來臺就學，並以一次為限。

外國學生經入學學校以操行或學業成績不及格、違反法令或校規情節嚴重致遭退學或喪失學籍者，不得再依前項規定申請入學。

九、外國學生入學申請之審查，依下列程序行之：

(一) 國際事務組收件後進行資格審查，詳細核對申請人之資格及各項表件是否符合及齊備後，並送交學系、學程進行初審，學系、學程得視需要安排相關考試(含語言能力測驗)。

(二) 學系、學程將初審通過者，提送本校招生委員會議複審。

(三) 複審錄取者，經校長核定後，發錄取入學許可。

初審或複審未獲錄取者，除由教務組另函通知外，各項申請表件(不含所附證明文件正本)及所繳費用均不予退還。

九之一、外國學生所繳入學證明文件有偽造、假借、塗改等情事，應撤銷錄取資格；已註冊入學者，撤銷其學籍，且不發給任何相關學業證明；如畢業後始發現者，應由本校撤銷其畢業資格並註銷其學位證書。

十、外國學生不得申請就讀本校所辦理回流教育之進修學士班、碩士在職專班及其他僅於夜間、例假日授課之班別。但外國學生在臺已具有合法居留身分者或其就讀之班別屬經教育部專案核准之課程者，不在此限。

十一、入學許可應載明外國學生之姓名、就讀學程名稱、學位別、授課語言、入學之學年、學期開始日期、學雜費收退費基準、獎助學金及其他應告知外國學生之相關資訊之中文及英文版本，確認外國學生瞭解來臺就學相關權利義務，並得提供外國學生母國語言版本。

十二、核准入學之外國學生，應於規定日期完成註冊手續；如因重病或重大事故不能按時入學

時，應檢具有關證明，於註冊截止日前，向本校申請保留入學資格一年。因簽證或其他特殊事故不能按時註冊，應檢具有關證明，逕向本校申請延期註冊，未逾該學年第一學期修業期間三分之一者，於當學期入學；已逾該學年第一學期修業期間三分之一者，於第二學期或下一學年註冊入學。但教育部另有規定者，不在此限。

十三、 外國學生註冊時，新生應檢附已投保自入境當日起至少六個月效期之醫療及傷害保險，

在校生應檢附我國全民健康保險等相關保險證明文件。

前項保險證明如為國外所核發者，應經駐外機構驗證。

十四、 外國學生入學本校後，其轉學、休學、退學或變更、喪失學生身分等情事，應即時於教育部指定之外國學生資料管理資訊系統登錄。

成績考核及其他有關事項，依本校學則暨相關規定辦理。

十五、 外國學生於本校畢業後，經本校核轉教育部許可在我國實習者，其外國學生身分最長得延長至畢業後一年。

外國學生來臺就學後，其於就學期間許可在臺初設戶籍登記、戶籍遷入登記、歸化或回復中華民國國籍者，喪失外國學生身分，應予退學。但入學方式與我國內一般學生相同者，及依國籍法第四條第一項第一款至第三款申請歸化取得中華民國國籍者，不在此限。

外國學生經入學學校以操行、學業成績不及格或因犯刑事案件經判刑確定致遭退學者，不得再依本規定申請入學。

就讀我國學校且在學之學士班外國學生轉學本校者，依本校學士班學則及佛教學系學士班新生暨轉學生招生規定辦理。轉學生註冊入學，其學分抵免得依本校學分抵免辦法辦理。但不招收正在境外學校就讀者。

外國學生如有休、退學或變更、喪失學生身分等情事，國際事務組應通報外交部領事事務局及本校所在地之內政部移民署服務站，並副知教育部。

外國學生有違反就業服務法之規定經查證屬實者，本校應即依規定處理。

十六、 本校因國際學術合作計畫或其他特殊需求需成立外國學生專班者，應依專科以上學校總量發展規模與資源條件標準相關規定，報教育部核定。

十七、 本校外國學生入學申請由國際事務組負責辦理，休、退學或變更、喪失學生身份等案件由教務組負責處理；學業之輔導、考核、聯繫等事項由其就讀學系、學程負責。

平時生活之輔導、考核、聯繫等事項由課外活動與生活輔導組負責。

課外活動與生活輔導組應於每學年度，不定期舉辦外國學生相關輔導活動。

十八、 外國學生就學應繳之費用，依下列規定辦理：

(一)經駐外機構推薦來臺就學之外交部臺灣獎學金受獎學生及具我國永久居留身分者，依本校所定我國學生收費基準辦理。

(二)依教育合作協議入學者，依協議規定辦理。

(三)前二款以外之外國學生，依其本校所定外國學生收費基準，並不得低於同級私立學校收費基準。

依「教育部外國學生來臺就學辦法」，中華民國一百年二月一日修正施行前已入學之學生，該教育階段應繳之費用，仍依原規定辦理。

十九、 本規定未盡事宜，依教育部「外國學生來臺就學辦法」暨本校相關規定辦理之。

二十、 本規定經招生委員會議通過，陳請校長核准，並報教育部核定後公布實施，修正時亦同。

1. These Regulations are formulated in accordance with Article 6 of the “*Regulations Regarding International Students Undertaking Studies in Taiwan*” of the Ministry of Education (MOE) of the Republic of China (ROC).
2. International students applying for admission to the University to study for a degree programme or enrolling in one of the courses offered by the University shall be handled in accordance with the Regulations.

The University shall establish an admission handbook for international students, which shall include the admission methods, procedures for eligibility screening, medium of instruction of individual departments (programmes), requirements for language proficiency, criteria for financial certification, along with other relevant matters. The handbook shall be published annually according to the admission schedule on the University’s admissions website and official social media, and shall be publicized internationally through the Dharma Drum Mountain Global Website.

The University does not delegate the admission of international students to any third-party organizations, legal entities, groups, or individuals, except for necessary activities related to publicity, promotion, and assistance regarding students’ arrival in Taiwan, and does not charge international students any fees related to the admission process. All application procedures for admission and related provisions shall be governed by the Regulations and the admission handbooks of the current year.

3. Individuals who meet one of the following eligibility requirements may apply for admission in accordance with the Regulations:
 - 3.1 Foreign nationals who do not have R.O.C. nationality and meet the following requirements may apply for admission in accordance with the Regulations:
 - 3.1.1 Those who have never studied in Taiwan as overseas Chinese students.
 - 3.1.2 Those who have not been granted admission by the University Entrance Committee for Overseas Chinese Students in accordance with the Regulations Regarding Study and Counseling Assistance for Overseas Chinese Students in Taiwan in the academic year in which they apply for admission.

3.2 Foreign nationals who meet the following requirements and have recently resided overseas for more than six consecutive years may also apply for admission in accordance with the Regulations:

3.2.1 Those who also have R.O.C. nationality at the time of application shall have never had a household registration in Taiwan.

3.2.2 Those who used to have R.O.C. nationality before submitting the application but no longer have R.O.C. nationality at the time of application shall have passed eight years from the date of the Ministry of the Interior's permission for renunciation of R.O.C. nationality to the time of application.

3.2.3 Applicants who satisfy the previous two items shall not have studied in Taiwan as overseas Chinese students and shall not have been granted admission by the University Entrance Committee for Overseas Chinese Students in the current academic year.

Foreign nationals who are selected and recommended by foreign governments, organizations or educational institutions to study in Taiwan in accordance with educational cooperation agreements, and who have never had household registration in Taiwan, may be exempted from the restrictions of the preceding paragraph with the approval of the Ministry of Education.

The 'six years' and 'eight years' referred to in Subparagraph 2, Paragraph 1, are defined as the commencement date of the term of study in which the student seeking admission (February 1 or August 1) for the calculation of the end date.

The term 'overseas' in Subparagraph 2, Paragraph 1 refers to countries or regions other than Mainland China, Hong Kong and Macao. The term 'continuous residence' refers to the period of stay in the Republic of China for international students not exceeding 120 days per calendar year. If the starting and ending years of the period of continuous residence overseas are not full calendar years, the period of stay in the Republic of China during the period of time of each year shall be recognized as not exceeding 120 days.

Nevertheless, those who meet one of the following criteria and possess relevant documents are not subject to such restrictions, and their period of stay in the Republic of China shall not be included in the calculation of the period of overseas residence:

- (1) Those who are enrolled in technical training courses for overseas youth organized by the competent authorities of overseas community affairs or technical training courses approved by the Ministry of Education.
- (2) Those who have studied in the Mandarin training centres of universities and colleges approved by the Ministry of Education to enroll international students for less than two years in total.
- (3) Exchange student whose aggregate exchange period has not exceeded two years.
- (4) Those who have been permitted by the Central Competent Authority for the purpose of internship in Taiwan, and the total period of internship is less than two years.

Foreign nationals who also have R.O.C. nationality and have applied for renunciation of R.O.C. nationality prior to the implementation of the amendment to the Regulations Regarding International Students Undertaking Studies in Taiwan by the Ministry of Education on February 1, 2011, may apply

for admission in accordance with the original Regulations, and are not subject to the provisions of the first paragraph.

- 4 Foreign nationals who are also eligible for permanent residence in Hong Kong or Macao, and have never had a household registration in Taiwan, and have resided continuously in Hong Kong, Macao or overseas for at least six years at the time of application may apply for admission in accordance with the Regulations.

Continuous residence, as stipulated in the preceding paragraph, refers to the period of stay in the country not exceeding 120 days in total per calendar year. However, those who fulfil one of the circumstances listed in subparagraphs 1 to 4 of Paragraph 3, Article 5 and possess relevant documents are exempted from such restrictions. The period of stay in the Republic of China shall not be included in the calculation of the period of continuous stay in the preceding paragraph.

Those who have been residents of Mainland China with foreign nationality and have never had a household registration in Taiwan, and have resided overseas continuously for more than six years at the time of application may apply for admission in accordance with the Regulations.

Continuous residence, as stipulated in the preceding paragraph, refers to the period of stay in the country not exceeding 120 days in total per calendar year. However, those who fulfil one of the circumstances listed in subparagraphs 1 to 4 of Paragraph 3, Article 5 and possess relevant documents are exempted from such restrictions. The period of stay in the Republic of China shall not be included in the calculation of the period of continuous stay in the preceding paragraph.

The term ‘six years’ as stipulated in paragraphs 1 and 3 shall be defined as the commencement date of the semester in which the student seeking admission (February 1 or August 1) for the calculation of the end date. The term overseas as stipulated in paragraphs 1 to 4 shall be deemed to be subject to the provisions of Paragraph 4, Article 3.

- 5 The actual enrollment of international students shall be based on the principle that its quota shall be 10% more than the quota approved by the Ministry of Education for the current academic year and shall be combined with the total enrollment of the previous academic year to be reported to the Ministry of Education for approval. In case the quota of international students exceeds the quota of 10% more than the quota approved for the previous academic year, a plan for increasing the number of students enrolled shall be proposed (including the quality control strategy and supporting measures), which shall be reported to the Ministry of Education for approval. However, this is not the case for degree programmes in which the University cooperates with foreign universities and which have been approved by the Ministry of Education. If the total enrollment quota for the previous academic year is insufficient for local students, the University may fill the quota with international students and shall submit the plan to the Ministry of Education for approval.

The admission quota specified in the first paragraph shall exclude international students who have not yet obtained the formal enrolment status.

- 6 International students applying for admission to the University for degree programmes shall possess the following qualifications:

- 6.1 Those who meet the admission requirements for degree programmes at respective levels or have

the equivalent educational qualifications as those of the educational system of the Republic of China.

6.2 Those who have not been subject to expulsion from a domestic educational institution on the basis of failing conduct and/or academic performance, or due to a criminal offence for which a prison sentence has been imposed.

6.3 Academic qualifications: A passing grade point average at the original institution of graduation or passing the graduation examination as required by the educational system of the country concerned.

6.4 Chinese language proficiency: All departments and programmes are taught in Chinese. Applicants shall have the ability to listen, speak, read, and write in Chinese:

6.4.1 Applicants for undergraduate studies shall possess Chinese proficiency equivalent to Level A2 Basic in the Test of Chinese as a Foreign Language (TOCFL).

6.4.2 Applicants for master's and doctoral programmes shall possess Chinese proficiency equivalent to Level B1 Advanced in the Test of Chinese as a Foreign Language (TOCFL).

6.4.3 The certificate of Test of Chinese as a Foreign Language (TOCFL) may be waived in the following cases:

6.4.3.1 Applicants for admission to a master's programme or above, with the previous programme being studied in the Republic of China.

6.4.3.2 Applicants who were born in Mainland China with Chinese as their mother tongue.

6.4.3.3 Applicants who are Malaysian nationals and have studied in a national secondary schools with Chinese as the medium of instruction or Chinese independent high schools in Malaysia may be exempted from the requirement to submit the above mentioned certificates of Chinese language proficiency.

6.5 Applicants who have passed the initial screening may be required to attend an oral examination organized by the University on a case-by-case basis.

7 Applicants who meet the eligibility criteria shall submit their applications to the International Affairs Section of the University with the documents listed below by the deadline stipulated in the admission handbook of the current academic year:

7.1 Application form in duplicate (each with a 2-inch half-body photo without wearing any hat).

7.2 A photocopy of the passport.

7.3 Documentary proof of academic qualifications:

7.3.1 Qualifications obtained in Mainland China: The requirements stipulated in the *Regulations Governing the Recognition of Academic Qualifications from Mainland China* shall be followed.

7.3.2 Qualifications obtained in Hong Kong or Macao: The requirements stipulated in the *Regulations Governing the Examination and Recognition of Educational Records from Hong Kong and Macao* shall be followed.

7.3.3 Qualifications obtained from other countries or regions:

7.3.3.1 The academic qualifications of overseas Taiwanese schools and Taiwan children's schools in Mainland China shall be considered equivalent to the academic qualifications obtained from schools of the same level in Taiwan.

7.3.3.2 Qualifications from overseas educational institutions other than those stipulated in the previous two items shall be handled in accordance with the *Regulations Governing the Assessment and Recognition of Foreign Academic Records by Institutions of Higher Education*. However, the qualifications of foreign schools whose campuses or branches are located in Mainland China shall be verified by a notary public office in Mainland China and by an organization established or designated by the Executive Yuan, or by a private organization commissioned by the Executive Yuan.

7.4 Proof of sufficient financial resources to study in Taiwan (at least NTD 120,000 or USD 4,000 for upāsakas and NTD 30,000 or USD 1,000 for anagārikas), or proof of a full scholarship from the government, the University, or a non-government organization.

7.5 A copy of the study plan written in Chinese (including the purpose of study, duration and future prospects).

7.6 A copy of recommendation letter.

7.7 Other documents required by the departments, graduate institutes, and degree programmes in which the applicants wish to enroll.

Applicants are limited to enrollment in one department, graduate institute, degree programme, and one level of degree or elective study.

International students who have completed academic degrees at bachelor's level or above in Taiwan and continue to apply for admission to the University's postgraduate programmes at master's level or above may apply for admission by presenting the graduation certificates and academic transcripts of the previous years of the respective institutions in the Republic of China in accordance with the provisions of the first paragraph, and shall not be subject to the provisions of Subparagraph 3, Paragraph 1. When examining applications for admission of international students, the University may request verification of documents mentioned in Subparagraphs 3 to 4, Paragraph 1, which have not been verified by the overseas organizations of the Republic of China, or by organizations established or designated by the Executive Yuan, or by private organizations commissioned by the Executive Yuan in case of doubt. For documents that have already been verified, the University may request assistance in verifying the authenticity of the documents.

International students who have graduated from an overseas Chinese school or a bilingual department (class) attached to a senior high school or a foreign programme department (class) of a private senior high school in the Republic of China may apply for admission in accordance with the provisions of Article 7 with a certificate of graduation and academic records of the previous years of study of the school, and shall not be subject to the limitations of the provisions of Article 8 and the provisions of Subparagraph 3, Paragraph 1, Article 7 of the Regulations.

8 Applications by international students to study in Taiwan in accordance with the provisions of Articles 3 and 4 shall be limited to once only. Those who pursue further studies in Taiwan shall be enrolled in the same manner as the general students in Taiwan. However, the following circumstances shall not apply:

8.1 International students applying for admission to programmes above the master's degree level at the University after completing their studies at their respective institutions of study may apply for admission either in the same manner as general students in Taiwan or in their capacity as international students.

8.2 International students who apply to study in Taiwan for a programme up to the bachelor's degree level and who have stayed in Taiwan for not more than one year and who have been withdrawn from school or have forfeited their enrollment for any reason may re-apply to study in Taiwan for one time only.

International students who have been expelled or disenrolled from their original institutions due to unsatisfactory conduct or academic performance, criminal offences or serious violations of school rules shall not re-apply for admission in accordance with the provisions of the preceding paragraph.

9 The following procedures shall be followed in examining applications for admission of international students:

9.1 The International Affairs Section conducts an eligibility check upon receipt of the application. Upon verification of the applicant's qualifications and checking of the completeness and accuracy of all documents, the application shall be forwarded to the department (programme) for initial screening, and the department (programme) may schedule relevant examinations (including language proficiency tests) as necessary.

9.2 Departments and programmes shall submit those who have passed the initial screening to the Admissions Committee of the University for further review.

9.3 After the review, admission letter shall be issued to the applicant upon the approval of the President of the University.

Applicants who have not been admitted after the initial screening or further review, unless notified by the Academic Affairs Section in a separate written correspondence, shall not be entitled to any return of the application documents (excluding the originals of the accompanying supporting documents) and refund of the fees paid.

International students shall be disqualified from admission in the event of forgery, falsification, or alteration of their admission documents. Those who have already enrolled in the University shall be disqualified from enrollment and shall not be issued any relevant academic certificates. In the event that such cases are discovered after graduation, they shall be disqualified from graduation by the University and their degree certificates shall be revoked.

10 International students shall not apply for enrollment in bachelor's degree programmes for recurrent education, in-service master's degree programmes, or other classes offered only in the evening or on regular holidays offered by the University. However, international students who have the legal status of residence in Taiwan or whose classes are approved by the Ministry of Education shall be exempted from such

restrictions.

- 11 The letter of admission shall contain the name of the foreign student, the name of the course of study, the degree, the medium of instruction, the year of enrollment, the commencement date of the semester, the basis for the collection and refund of tuition and miscellaneous fees, scholarships, and other relevant information that should be communicated to the foreign student, in both Chinese and English, with the aim of confirming that the foreign student understands the rights and obligations related to studying in Taiwan, and may be provided with a version of the native language of the foreign student concerned.
- 12 International students who have been approved for enrollment shall complete the enrollment procedures within the stipulated period of time. In the event that a student is unable to enroll on time due to serious illness or accident, they shall apply to the University for a one-year extension of their enrollment status before the registration deadline. In the event that a student is unable to register on time due to a visa issue or other special circumstances, they shall apply for an extension of their registration by submitting supporting documents to the University. In case the date has not yet exceeded one-third of the period of study of the first semester of the academic year concerned, the student shall be enrolled in that semester. In case the date has exceeded one-third of the period of study of the first semester of the academic year concerned, the student shall be enrolled in the second semester of that academic year or in the following academic year. However, exceptions shall be made by the Ministry of Education.
- 13 International students shall provide proof of medical and accident insurance for at least six months from the date of entry into the Republic of China at the time of their registration. Currently enrolled students shall attach documents proving that they are insured under the National Health Insurance or other relevant insurance policies. In case such insurance certificates are issued by foreign countries, they shall be verified by diplomatic missions of the Republic of China in the respective countries.
- 14 Upon enrollment, any transfer, suspension, withdrawal, change, or termination of student status of an international student shall be immediately recorded in the international student data management information system designated by the Ministry of Education.

Assessments of students' academic performance and other related matters shall be handled in accordance with the University's Academic Regulations and relevant rules and regulations.

- 15 Upon graduation from the University, international students who have been approved by the University and referred to the Ministry of Education for permission to undertake internships in the Republic of China are allowed to extend their status as international students for a period of up to one year after their graduation.

International students who come to Taiwan to study and who are permitted to register their initial household registration, transfer their household registration, naturalize or revert to R.O.C. nationality during their period of study shall lose their status as international students and shall be withdrawn from the school. **However, this shall not apply to those who are enrolled in the same manner as the general students in the Republic of China and those who apply for naturalization to acquire R.O.C. nationality in accordance with Subparagraphs 1 to 3, Paragraph 1, Article 4 of the *Nationality Act*.**

International students who have been expelled from the University due to failure in conduct or academic performance

or who have been sentenced to imprisonment for criminal offences shall not be allowed to re-apply for admission in accordance with the Regulations.

Transferring international students who have been enrolled in a **bachelor's degree programme** at any institution of higher education in Taiwan shall be handled in accordance with the University's *Academic Regulations for Undergraduate Programmes* and the *Regulations Governing the Admission of New and Transfer Students to Bachelor's Degree Programmes of the Department of Buddhist Studies*. Transfer students who are enrolled in the University shall be granted **credit in accordance with the University's Regulations Governing the Transfer of Credits**. However, no students who are currently enrolled in an overseas institution shall be admitted to the University.

The International Affairs Section shall notify the Bureau of Consular Affairs of the Ministry of Foreign Affairs and the **Service Center of the National Immigration Agency of the Ministry of the Interior where the University is located**, as well as inform the Ministry of Education in case of any suspension, withdrawal, change, or termination of student status of any international students.

In the event that an international student is found to have violated the provisions of the *Employment Service Act*, the University shall immediately handle the case upon substantiation in accordance with the relevant laws and regulations.

- 16 In case the University intends to set up dedicated classes for international students due to international academic cooperation programmes or other special needs, such plans shall be reported to the Ministry of Education for approval in accordance with the relevant regulations on the total development scale and resource conditions of junior colleges and institutions of higher education.
- 17 The International Affairs Section shall be responsible for handling applications for admission of international students. The Academic Affairs Section shall be responsible for cases of suspension, withdrawal, as well as change or termination of student status. Academic counselling, assessment, and communication shall be handled by the department or programme in which the student is enrolled. The Extracurricular Activities and Student Life Section shall be responsible for the counselling, assessment and communication with students in their daily lives. The Extracurricular Activities and Student Life Section shall organize counselling activities for international students from time to time during each academic year.
- 18 The fees payable by international students shall be governed by the following regulations:
 - 18.1 Scholarship recipients of the Ministry of Foreign Affairs (MOFA) Taiwan Scholarship who are recommended by the diplomatic missions of the Republic of China (R.O.C.) to come to Taiwan for study and those who are permanent residents of the R.O.C. will be subject to the tuition fees for local students as determined by the University.
 - 18.2 Students enrolled under educational cooperation agreements shall be handled in accordance with the provisions of such agreements.
 - 18.3 For international students other than those mentioned in the previous two subparagraphs, the fees shall be determined in accordance with the tuition standards for international students set by the

University and shall not be lower than the tuition standards for private institutions of the same level. International students enrolled in the University prior to the implementation of the Ministry of Education's Regulations Regarding International Students Undertaking Studies in Taiwan, as amended on 1 February 2011, shall continue to be subject to the original regulations regarding the fees payable at that stage of education.

- 19 Matters not covered in the Regulations shall be handled in accordance with the “*Regulations Regarding International Students Undertaking Studies in Taiwan*” of the Ministry of Education and the relevant rules and regulations of the University.
- 20 The Regulations have been passed by the Admission Committee Meeting, submitted to the President for approval, and reported to the Ministry of Education for approval prior to promulgation and implementation, and the same shall apply to any amendments.
